Accelerating Economic Transition in Tunisia and the Arab World

When the World Economic Forum polled experts and leaders on the most significant issues globally for 2014, rising societal tensions in the Middle East and North Africa, youth unemployment, and income inequality were their top three concerns. These issues, which are highlighted in the Outlook on the Global Agenda 2014 report, play a central role in the political and economic stability of many Arab countries. Tunisia's process recently resulted in a consensual constitution, putting the transitional political process on track. Yet, besides the success of the national dialogue, the challenges of Tunisia's economic transition persist.

This panel will explore what role business, government and media leaders can play in solving these challenges and helping accelerate their countries' economic transition. It will touch on the following dimensions:

- building the right climate for investment
- social justice and economic development
- from polarization to pluralism.
