## 1. Context

The 21st edition of the Tunisia Investment Forum (TIF): « EU-Tunisia Business Forum », will be held on June 12 and 13, 2024, in Tunis, under the theme "Tunisia, Where Sustainability Meets Opportunity". TIF 2024 aims to spotlight Tunisia's steadfast commitment to sustainable development while showcasing investment prospects across diverse sectors. This major event, jointly organised by "Invest in Tunisia Agency" (FIPA), under the aegis of the Ministry of Economy and Planning, and the European Union (EU) is a leading economic gathering in Tunisia. This year's special edition, « EU-Tunisia Business Forum », highlights the strong and ongoing partnership between Tunisia and the EU and shared commitment to fostering investment and collaboration between the two shores of the Mediterranean.

As part of its investment climate program in Tunisia funded by EU and the State Secretariat for Economic Affairs (SECO), the International Finance Corporation (IFC) is helping the Tunisian government improve the business climate to create an impact in terms of investment and job creation. This forum will also be an opportunity to highlight the objective of increasing Tunisia's capacity to support the green and digital transitions currently required to enable Tunisia to remain on the radar of investors and remain competitive by joining the new international dynamic linked to corporate social responsibility. Indeed, Tunisia is looking to attract even more FDI into high value-added activities that are in line with the Sustainable Development Goals (SDGs) to generate quality jobs, promote inclusion, and support the benefits of sustainable development.

This edition of the TIF will be complemented by side events, notably on the themes of aftercare and investment quality. The side event on investment aftercare aims to highlight the importance of aftercare services in ensuring the sustainable success and growth of investments.
